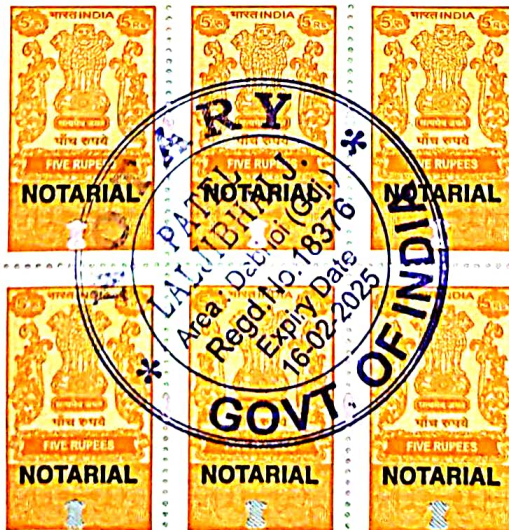
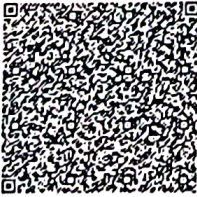

## MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (The "Document") made as of 07.07.2023 (the "Execution Date")

BETWEEN:

Smt. S. C. P. F. Commerce College Dabhol

AND

Human Resource Skill Development Centre of Vadodara (HRSDC)

(the "Party")

### **Background:**

This Document will establish the basic terms to be used in a future agreement between the Parties. The terms contained in this Document are not comprehensive and it is expected that additional terms may be added, and existing terms may be changed or deleted. The basic terms are as follows:

### **Preamble:**

- Whereas, Smt. S. C. P. F. Commerce College, Dabhol has been successfully running various Academic Courses in the field of Commerce and Management.
- Whereas, Human Resource Skill Development Centre (HRSDC) has been running various students development programs at its various training centres at Vadodara and other parts of India in align with responsibility of Training technical and skilled manpower in various frontline areas of Importance such as Students Career Development Counselling, Competitive Exam Preparation, Industrial Skill Training, various Vocational Skill Training, Classical Vocal Training, Sports Education Training, CSR activities with various organizations, Motivational Training etc.

Whereas, both Smt. S. C. P. F. Commerce College, Dabhol and HRSDC now onwards will be dealing with following activities:

- Recognizing the importance of Students Career Counselling and overall development of students and make them ready for soft skills and important workforce of the state.
- Appreciating the need for creation of large reservoir of highly qualified manpower in all the fields related to Commerce, Accounts, Management, Industrial Skill Manpower and society in general.
- Desiring to club their efforts by using their expertise and resources, intend to form a nucleus for promoting excellent quality students and make Skilled Manpower in all the areas of Economy and special emphasis on the blue collared manpower and related fields etc.
- Now, therefore, in consideration of mutual promise made herein, and of good and valuable consideration, the receipt and sufficiency of which both Smt. S. C. P. F. Commerce College, Dabhol

and HRSDC hereby acknowledge, Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC hereby agree to sign a Memorandum of Understanding in this respect.

### Goals and Objectives:

- Both Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC shall encourage interaction between students and faculty members of Smt. S. C. P. F. Commerce College, Dabhoi.
- Organizing joint seminars/ conferences/ workshops.
- Arrangement of training for students of Smt. S. C. P. F. Commerce College, Dabhoi.
- Make the plans for various training programs for students' development.
- Overall objective and goals are to make each and every student be ready for future workforce for the Nation by conducting Counselling, training etc.

To conduct various government, semi-government, private industry employment-oriented programs and necessary training.

### Sharing of Facilities:

- Smt. S. C. P. F. Commerce College, Dabhoi shall make provisions to share their infrastructure and other required facilities to promote academic excellence and career counselling aid.
- HRSDC shall provide Career Counsellors, Training Mentor, training related resources and others as and when required.

### Coordination of Programmes including Financial Arrangements:

- The collaborative programme between Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC shall be coordinated by a coordination committee appointed by the Directors of both the Institutions.
- Financial arrangements for each specific collaboration will be borne by HRSDC and will be decided on case-to-case basis and brought on record in each case after due approval from Heads of both the Institutions.

### Effective Date and Duration of MoU:

- This MoU shall be effective from the date of its approval by competent authorities at both ends.
- The duration of MoU shall be for the period of 3 years from the effective date.
- During its tenure, the MoU may be extended or terminated by prior notice of not less than one month by either party. However, termination of the MoU will not, in any manner, affect the interests of the students/faculties who have been involved pursuing a programme under the MoU.
- Any clause or article of the MoU may be modified or amended by mutual agreement of Smt. S. C. P. F. Commerce College, Dabhoi Dabhoi and HRSDC.

**Confidentiality:**

- During the tenure of the MoU both Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC will maintain strict confidentiality and prevent disclosure of all the information and data under the scope of this MoU for any purpose other than in the MoU.
- Both Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC shall bind their respective personnels who come into possession or knowledge of any confidential information, not to disclose the same to third party without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement of this MoU.

Further both Smt. S. C. P. F. Commerce College, Dabhoi and HRSDC shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

**Amendments:**

- Any amendment and/or agenda to the Agreement shall be in writing and duly signed by both the PARTIES hereto and shall only after such execution, be deemed to form part of the Agreement and have the effect of modifying the Agreement to the extent required by such amendment or agenda.

**Resolution of Disputes:**

- This agreement shall take effect and be construed in accordance with the Laws of India and be Subject to the jurisdiction of the courts at Vadodara.
- The dispute or difference whatsoever arises between two PARTIES in relation to or in connection with this Agreement, both the parties shall first try to resolve the dispute /difference amicably between themselves, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of the Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be Vadodara and the language of Arbitration shall be English.
